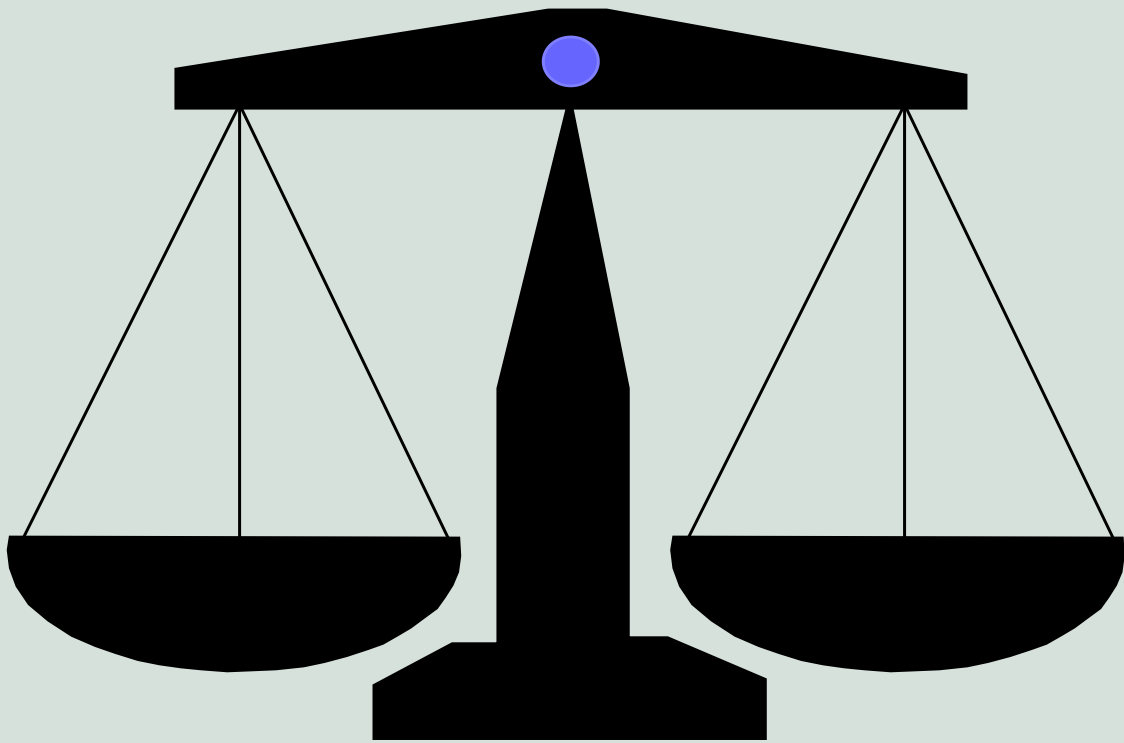

## What do students who want to go to law school major in?

The American Bar Association (ABA) has stated that it:

does not recommend any undergraduate majors or group of courses to prepare for a legal education. Students are admitted to law school from almost every academic discipline. . . . Whatever major you select, you are encouraged to pursue an area of study that interests and challenges you, while taking advantage of opportunities to develop your research and writing skills. Taking a broad range of difficult courses from demanding instructors is excellent preparation for legal education. A sound legal education will build upon and further refine the skills, values, and knowledge that you already possess.\*

Students should be aware that the Law School Admissions Test (LSAT), an important component of the student’s application to law school, asks questions designed to test analytic and reasoning skills but does *not* include questions regarding the content or substance of the law itself.

Accordingly, TCNJ has no designated or preferred major for students who want to go to law school. We strongly encourage students to choose majors in areas of great interest to them and that challenge them. ## What are the components of TCNJ's Prelaw Program?

All components of the Prelaw Program are designed to help students prepare for the law school application process, for law school itself and for the practice of law.

The **Law and Society Interdisciplinary Concentration** and the **Law, Politics and Philosophy Interdisciplinary Minor** are designed to give students some experience in studying the law and help students hone their skills in critical reading, analysis and problem-solving. The programs are meant to give students an *idea* of what studying the law will be like since the law schools themselves take on the job of teaching students the law while the LSAT focuses on analytic reasoning skills and asks nothing about the content or substance of the law at all.

The **Interdisciplinary Concentration** requires six courses and allows students to satisfy some of their liberal learning requirements by taking courses related to law. The **Interdisciplinary Minor** performs a similar function but requires only five courses. Members of the Prelaw Advisory Committee also serve as advisors for this minor. For more information, please see Appendix A below and <http://prelaw.pages.tcnj.edu/>.

The **Designated Prelaw Advisor Program** insures that all interested students are assigned a Designated Prelaw Advisor. This advisor, a member of the Prelaw Advisory Committee, supports and advises students who may be interested in attending law school through all steps of the law school application process, from the choice of major and courses to preparation for the LSAT to deciding which law schools to apply to and how to evaluate offers from different law schools. Students are also welcome to consult with any other member of the Prelaw Advisory Committee as they please!

**Prelaw Information Sessions** are typically held once a semester. All are welcome. Topics include how to prepare for the law school admissions process (including a “to do” list) and how to make use of the on-line resources available from the Law School Admissions Council (LSAC) and other sources (including the ABA-required 509 reports and employment reports).

The **Prelaw List** is a means of communicating with students who are interested in going to law school. For inclusion on this list, interested students should contact Melinda Roberts ([robertsm@tcnj.edu](mailto:robertsm@tcnj.edu)) with their names, email addresses, current or projected major and year of graduation.

The **Prelaw Society**, a student-run organization, sponsors programs designed to inform prelaw students about subjects of interest. Students who wish to join the Prelaw Society can do so by emailing the organization at [prelawsc@tcnj.edu](mailto:prelawsc@tcnj.edu).

**Internships** can be of great interest to prelaw students. Students seeking internships may contact the Career Center. Students interested in applying for the one-semester Washington Center Program should contact the Center for Global Engagement. Academic credit received in connection with an internship must be approved by the student’s own major department.

**Prelaw Center.** The Prelaw Center is located in Bliss 103 and houses information regarding particular law schools as well as the law school admissions process. Due to restrictions relating to Covid 19, the office was closed during the last academic year. When it reopens, students will be warmly invited to drop in anytime!
